Mackintosh International Teams Match

Administration:

Sept 30th in year prior to competition - Invite Participants for the following year.

July 30th in year of competition - Event closed and scores collated. Add to website.

August - (within two weeks of close date) in year of competition

Notify all participating Countries of results. Send relevant badges to winners and runners up.

45 winners badges will be made, all 25 of the senior team are given a badge, as with all 5 members in the winning Ladies, Junior's Veterans and Super Veterans teams.

45 runners up badges will be produced and given out to all team members as above.

Publish results in next available Clay Target Shooting News.

Mackintosh International Teams Match

Details: The Mackintosh International Teams Match is conducted under the direction of the Australian Clay Target Association.

- Mackintosh International Teams Match 100t
- Ladies International Teams Match 100t
- Junior International Teams Match 100t
- Veterans International Teams Match 100t
- Super Veterans International teams Match 100t
- Juniors shall be less than 21 years of age on the 1st of January in the year of the competition.
- Veterans shall be aged 55 years or over on the 1st of January in the year of the competition.
- Super Veterans shall be aged 65 or over on the 1st of January in the year of the competition,

Conditions of Competition

Entry fee:

Each competing country shall pay, if requested, an entry fee to an amount as determined by the organising association, the Australian Clay Target Association, to cover the costs of badges and postage.

Teams:

To comprise of:

- (a) Open Team 25 members (2 emergencies to be named)
- (b) Ladies Team 5 members (1 emergency to be named)
- (c) Junior Team 5 members (1 emergency to be named)
- (d) Veteran Team 5 members (1 emergency to be named)
- (e) Super Veterans team 5 members (1 emergency to be named) Each competing country shall determine the composition of their respective teams by the process of

elimination.

Squads:

To be determined by the position in which the shooter has qualified.

A shooter cannot represent two teams, he/she must declare Note:

before the event which team they are competing for. Eg

either Open or Junior, not both.

Each team member to be a citizen of the country for which Qualification:

they are competing for at least the twelve months prior to

competition.

Result: To be added to the Results recorded for previous years.

Competing Countries to provide scores to the ACTA by the

closing date of competition, the 6th of August. Close of Comp:

To be made available to all competing countries within 14 Final Results:

days of the results being publicly declared.

A winners badge to be made available to all members of the Recognition:

winning teams.

A runners up badge to be made available to all members of

the teams finishing in second place in the respective sections.

100 target event scored points score, first barrel 3 points, **Match Conditions:**

second barrel 2 points, lost target 0.

Shooters are warned that only shells with a maximum 28gr Ammunition:

(1oz) shot load are permitted.

Scores: The open team will consist of 25 members (top 20 scores to count).

The Ladies, Juniors Veterans and Super Veterans teams will each consist of five members (top 4 scores in each team to count).

Ties: If there is a tie then the points from the last round takes precedence and so on.

Traps: A minimum of four traps to operate for the open team event, one visit by each squad, to each trap, shooting 5 targets per lane before changing.

Ladies, Junior & Veterans and Super Veterans Teams: 100 Targets - Shot over two traps per team, shooting five targets per lane before changing.

Shooting

Mark:

15 metres or (if common usage, 16 yards)

Referees:

Each squad to be provided with:

(a) Referee (b) Check Referee (c) Two scorers

Referee and scorers to be selected by the appointed Shoot Marshall, and remain with the squad for the 100 targets.

Sighter: Each shooter to have one sighter target per lane before

commencement of events (Five targets to shoot at for each shooter,

not to count)

Refusal: Each shooter to have the right to refuse to fire at any target if it is

illegal in height ,angle or release.

A target once fired upon by any competitor is to be included in the

results, with each competitor abiding by the result.

Trap Settings:

(a) Height to be set in the usual manner as does apply for each competing country.

(b) Distance - targets shall be thrown a minimum of 48 metres (+/-2metres)

(c)Angles to be a minimum of 22.5 degrees each side of centre, using a line down lanes numbered 1 and 5 (note 22.5 degree is one metre outside the line at 50 metres.

General:

Each country to ensure that the rules of common sense and fair play are adhered to at all times.

No unfair advantage is to be taken owing to the competition being a team's match.

Shooting to be conducted in the normal manner at all times.

Tradition: As the Mackintosh International Trap Team Match is a long established event, all countries to be mindful of the part that fair play and tradition occupy in this international postal teams match, conditions of which have been revised and agreement reached by all competing countries.
